## **Guidelines for writing Field Work Report (MSW-I)**

Considering the present day situation it would not be safe for our learners to be placed in NGOs and be exposed to risk of getting infected by Coronavirus. In such a condition Dept. of Social Work under School of Professional Studies, NSOU, have tried to develop a strategy for conducting such training so that our learners may be safe on one hand but be able to gain Field Work knowledge without much difficulties. The learners would have to take up the following three tasks-

- **I. Section- A:** It may be conveyed that some of the Resource Persons working as higher officials in reputed NGOs and other Government Organizations particularly for the welfare of the communities have been already contacted on behalf of the University and they have given their kind consent to deliver a short lecture about the background of their organization along with history, mission & vision, objectives, areas of interventions and so on. In this way the learners would get an opportunity to know about these organizations without even visiting the organization but they would know about the organization from the concern authorities.
- II. **Section –B:** They would also have to write a case study of an NGO by looking into their website, reports & other disclosure available in public domain and try to relate its course of action with the methods of social work and also see how the organization is following the social work principles. They may give their observation and suggestions in this regard.
- **III. Section-C:** They may write a brief overview of COVID-19 situation in their own locality and comment on the activities taken up by the local self-government (Gram Panchayat or Municipality or Municipal Corporations as applicable), NGOs and give their view about the kind of social work interventions needed in their respective locality.

The report of all the three tasks should be written in three Sections as Task I, II & III in the same file. The final report must be comprises of all the three section in a compiled manner.

## Section A (Within 1000-1500 Words)

There are 5 A/V Lectures which were already delivered by our Resource Persons (External Expert) from various Organization. (The lectures may be find in our university LMS and in the Telegram Group of Field Work). Following points should be covered in this section.

Section B (Within 1000 Words)	
In this section the Learners would have to write an Essay based on their own observation regarding the socio economic situation of their area in which they are residing. In this section the learners may write their own experiences about the changing the social behaviour of the people around them and the various social problems that are emerging in their community. They would also mention about the role of local Govt. in tackling such situation. They would also have to mention the Social Work Interventions that they may apply to improve the social conditions of their community in the Covid Era.	
Section C (Within 500-1000 Words)	
The Learners may conduct an in-depth Research through secondary source like- Websites / Reports etc. and develop a write up about any two NGOs (National and International) by covering the following points.
